



# 2025 Supply Chain Transparency Report

This Report is being submitted by Mattr Corp. and relates to the financial year ending December 31, 2025. This Report was approved by the Mattr Corp. Board of Directors on March 12, 2026, in compliance with: (i) Canada's Fighting Against Forced Labour and Child Labour in Supply Chains Act (the "Act"); and (ii) the UK Modern Slavery Act 2015.



## WHO WE ARE

Mattr is a growth-oriented, global materials technology company broadly serving critical infrastructure markets, including electrification, transportation, communication, water management and energy. Its two primary business segments, Composite Technologies and Connection Technologies, operate a global network of manufacturing and technology centers, delivering differentiated, high-value products which enable renewal and enhancement of critical infrastructure. During 2025, these manufacturing and technology centers were located in Canada, the United States, the United Kingdom, Germany, the Netherlands and China.

On January 2, 2025, Mattr expanded its Connection Technologies segment through the acquisition of AmerCable Incorporated ("AmerCable"), a U.S. manufacturer of highly engineered wire and cable solutions. AmerCable's U.S.-based operations are covered by this report.

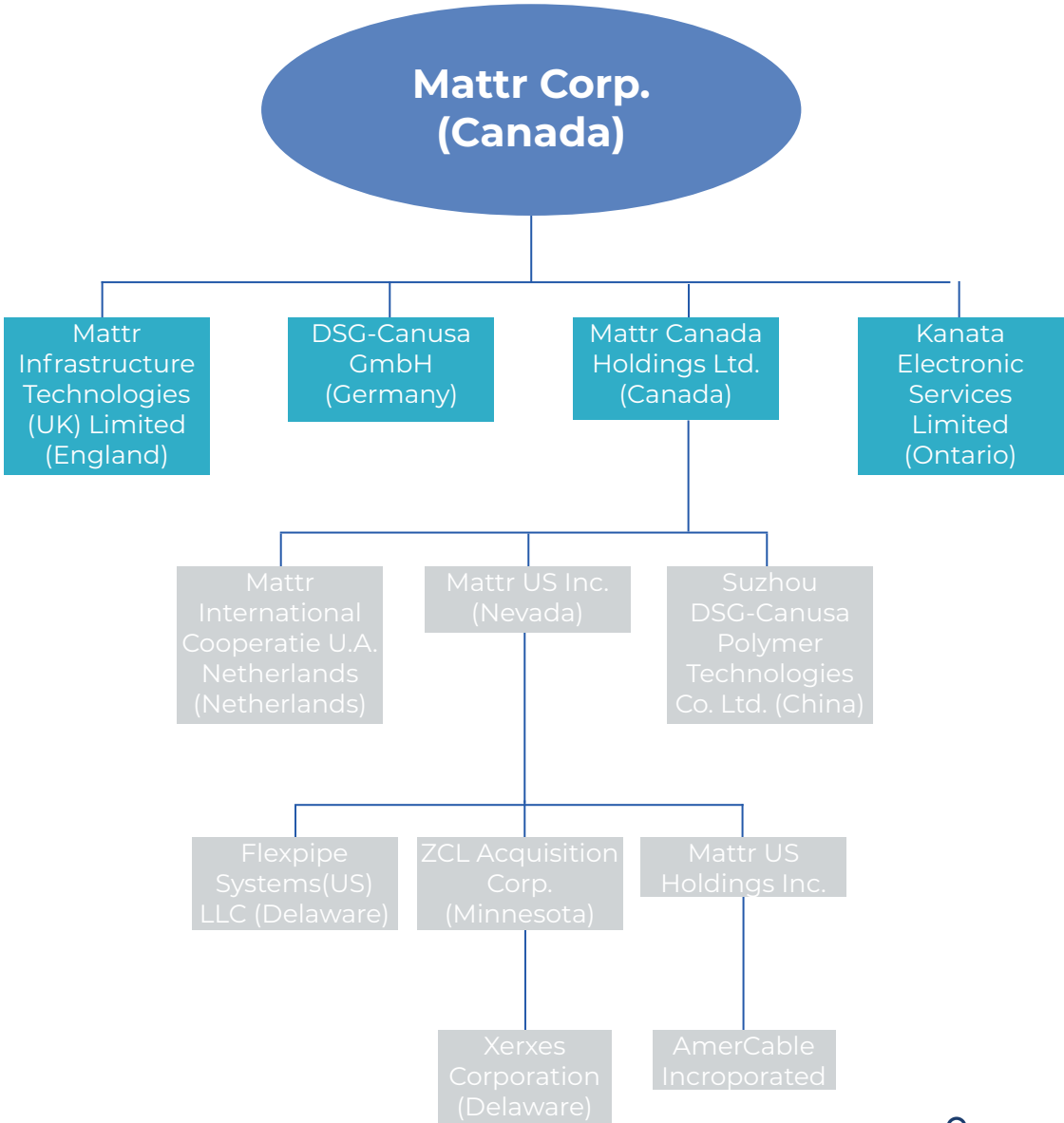
On November 30, 2023, Mattr completed the sale of a substantial part of its Pipeline Performance Group (PPG), whose product offering included specialized, proprietary internal and external corrosion protection systems, thermal insulation coating systems and concrete weight coating systems for onshore and offshore pipelines. This sale did not include certain elements of the PPG business, only one of which had substantive operations, the PPG pipe coating business in Brazil. In June 2025,

the Company completed the sale of its Brazilian pipe coating business. As the Brazilian operations were owned by the Company during the reporting period, they are covered by this Report.

Mattr is a corporation incorporated under the Canada Business Corporation Act and is listed on the Toronto Stock Exchange. Mattr’s headquarters are located at 336 Courtland Avenue, Vaughan, Ontario.

As at December 31, 2025, the Company employed 2,110 permanent and contract personnel, of which 747 were based in Canada and 1,363 were based outside of Canada.

# Our Business and Supply Chains

For over 50 years Mattr has delivered highly engineered technologies and solutions to support infrastructure projects around the world. From the lab to the field, we develop solutions that have generational impact. You can find our brands in energy, automotive, communication, water management, utilities, transportation and mining markets to name a few of the industries we serve.

Mattr delivers advanced materials technologies and complex manufacturing expertise. Our two primary business segments, Composite Technologies and Connection Technologies, operate through a portfolio of brands to offer highly engineered solutions, technology and products to support infrastructure projects and markets worldwide, helping to build a better tomorrow.



Xerxes delivers market-leading, composite underground liquid fuel storage tanks and stormwater management systems.



Flexpipe is a world leader in non-metallic composite spoolable pipe.



Shawflex provides highly engineered wire, cable and assemblies across industrial and infrastructure markets.



DSG-Canusa is globally respected for innovative heat-shrink and cold-applied tubing and sleeve products.



AmerCable is a globally recognized U.S. manufacturer of highly engineered wire and cable solutions used in critical infrastructure applications.

In addition to the Composite Technologies and Connection Technologies business segments, Mattr's PPG operations in Brazil specialize in providing thermal insulation coating solutions for the oil & gas industry in Brazil.

Mattr sources the materials and components it needs to manufacture the advanced materials solutions it provides to its customers globally, from suppliers located predominantly in North America but also in South America, Europe, Africa and Asia. A number of our suppliers located in North America are subsidiaries of parent organizations having their headquarters in other parts of the world. Major items sourced include polyolefin and other polymeric resins, iron ore, cement, adhesives, sealants, copper, fibreglass and other ferrous and non-ferrous wire. These materials and components are then imported into the country where the manufacturing will ultimately occur (see discussion under "Who We Are" above for a summary of manufacturing and technology center locations).

# Our Commitment to Human Rights

Mattr is committed to maintaining a corporate culture that respects the principles aimed at promoting, protecting and supporting all internationally recognized human rights. We recognize our responsibility to respect human rights and avoid complicity in human trafficking, worker exploitation, child labor, forced labor or other human rights abuses (“Human Trafficking,” “Worker Exploitation,” “Forced Labor” and “Child Labor” are collectively referred to herein as “**Human Rights Abuses**”). The individual terms that comprise the defined term, Human Rights Abuses, are terms used to describe situations where one person is exploited by another person for profit. These are broad terms that cover many types of exploitation that use force, fraud, coercion, deception, discrimination, or abuse of power. The following sections of this Report describe efforts taken, and being undertaken, by Mattr to prevent and reduce the risk that Human Rights Abuses are involved at any step in the production or importation of goods by Mattr.

## Governance Framework: Preventing/Reducing the Risk of Human Rights Abuses

## Parts of our Supply Chain Carrying Higher Risk of Human Rights Abuses

We are aware that certain regions and countries are generally known to carry a higher risk of Human Rights Abuses in specific sectors. Notably, we have consulted open-source intelligence on this issue such as information available from the International Labour Organization, among other information. Our critical, first-tier suppliers of materials and components that are inputs in our manufacturing process (**Manufacturing Inputs**), including those based in countries having a higher risk of Human Rights Abuses, have been included in Phase 1 of our Supplier Onboarding Enhancement Project (see discussion under “Due Diligence” below for more information).

## Our Action Plan for Enhancing Supplier Onboarding Processes

Over the course of 2023 and 2024, Mattr undertook a review of its existing policies and processes related to preventing and reducing the risk that Human Rights Abuses are engaged at any step of the production or import of goods by Mattr. While we are confident that our own operations are being conducted in accordance with all applicable laws and that Human Rights Abuses are not occurring within our own operations, the results of that review caused us to recognize the need to better understand the risk that Human Rights Abuses may be occurring within our supply chain. As a result, the Company embarked on a project to enhance our supply chain onboarding protocol (**Supplier Onboarding Enhancement Project**) to provide for consistent and more rigorous onboarding processes across our different business units with the goal of identifying and mitigating risks of Human Rights Abuses within our supply chain. Specifically, the Supplier Onboarding Enhancement Project involves implementation of:

- [A partnership with an external vendor to undertake enhanced due diligence screening as a critical component of our supplier onboarding protocol](#)
  - Mattr has partnered with Assent Compliance (Assent) to conduct a two-stage screening process on existing and new suppliers (see additional details below under the heading Due Diligence)
- [A requirement that our suppliers declare compliance with Mattr’s Supplier Code of Conduct at the time of onboarding and annually thereafter](#)
  - requires our suppliers to conduct their operations in a manner that demonstrates the same respect for human rights as Mattr has committed to and specifically confirms the following:
    - no use of child labour or forced labour or participation in human trafficking;
    - no payment of recruitment fees by workers;
    - a safe and healthy workplace free from discrimination and harassment;
    - compliance with all applicable laws, including those relating to working hours, and regulations on freedom of association and collective bargaining; and
    - providing wages and benefits that meet or exceed the national legal standards.

# Due Diligence

Assent offers a supply chain sustainability management solution which helps manufacturers gain transparency into their supply chains in order to mitigate the risk of Human Rights Abuses. The Assent Supply Chain Sustainability Platform facilitates the collection of data from our supply chain. Assent handles all supplier engagement, which is available in multiple languages, on our behalf and collects information from suppliers by issuing surveys on the following topics (**Human Rights Surveys**):

- Human Trafficking and Slavery
- Labor Rights
- Human Rights
- Organizational Commitment

These surveys are designed to collect data in a manner that aligns with internationally recognized standards: i.e. the Global Reporting Initiative (GRI), Organization for Economic Co-operation and Development (OECD), and Sustainability Accounting Standards Board (SASB).

Assent's Enhanced Supplier Screening (**ESS**) process offers a contactless solution for vetting suppliers for forced labor and other compliance risks, including sanctions, using ongoing monitoring of internet-accessible media and government-managed denied parties lists for potentially damaging mentions of suppliers, including ultimate beneficial owners. This service monitors over 2 million digital sources. The reports generated through the ESS process allows Mattr to quickly formulate and implement a mitigation plan in the event it learns of a high-risk situation within its supply chain.

While our goal is to achieve an adequate level of supply chain transparency to ensure that the manufacture of our products is not inadvertently contributing to Human Rights Abuses through our supply chain, we recognize that achievement of this goal will be a journey over the next few years. In recognition of that reality, we have adopted a phased approach to achieving our goal.

## Phase 1 of Supplier Onboarding Enhancement Project

Mattr began by implementing the first phase of its Supplier Onboarding Enhancement Project. Specifically, we developed the blueprint for the Supplier Onboarding Enhancement Project and completed certain key components of that program by:

- engaging Assent to conduct a two-stage supplier screening process on our behalf
- working with Assent to complete the first stage of such two-stage supplier screening process – the ESS screening - of our critical, first-tier suppliers of Manufacturing Inputs, being those suppliers with whom Mattr contracts directly
- working with Assent to launch the second stage of our two-stage supplier screening process - a campaign seeking completion, by our critical, first-tier suppliers of Manufacturing Inputs, of the Human Rights Surveys
- developing the Governance Framework referenced above

This first phase was focused on critical, first-tier suppliers of Manufacturing Inputs however we note our Supplier Code of Conduct requires these critical, first-tier suppliers to establish equivalent standards through their own activities and the management of their own suppliers and subcontractors.

## Phase 2 of Supplier Onboarding Enhancement Project

Over the course of 2025 and continuing in 2026, Mattr is working towards the implementation of the second phase of its Supplier Onboarding Enhancement Project which includes the following steps:

- complete development and roll-out of a New Supplier Onboarding App for the supply chain teams, including that of Mattr's recently acquired subsidiary AmerCable Incorporated, to use to conduct due diligence on new suppliers
- complete roll-out of the two-stage supplier screening process, through our partner, Assent, to the balance of our first-tier suppliers of Manufacturing Inputs, including to AmerCable's suppliers
- implement training and audit programs in respect of the Supplier Onboarding Protocol

## **Measures Taken to Remediate Human Rights Abuses within our Supply Chain**

The diligence campaign which we have undertaken has not, to date, disclosed any risk of Human Rights Abuses within our supply chain. As a result, we have not yet had cause to undertake measures to remediate Human Rights Abuses.

## **Measures Taken to Remediate Loss of Income to Families Impacted by Measures Taken to Remediate Human Rights Abuses**

As we have not yet had cause to undertake measures to remediate Human Rights Abuses, we have similarly not had cause to undertake measures to remediate loss of income experienced by families impacted by remedial measures taken to eliminate Human Rights Abuses.

## **Training of Mattr Employees on Protecting Against Human Rights Abuses/Assessment of Effectiveness of Supplier Onboarding Enhancement Project**


As noted above, implementation of training and audit programs falls within our Phase 2 objectives which have been rolled out and continue to be implemented through 2026.

During 2025 and continuing in 2026, Mattr conducted mandatory training sessions, based on materials developed internally, with its supply chain teams regarding the need to protect against Human Rights Abuses, as well as the role of the due diligence screening within the Supplier Onboarding Process, including the use of the New Supplier Onboarding App. Over the course of 2026, Mattr intends to implement the Audit Program described below.

**Audit Program:** To be comprised of (i) internal audit to confirm adoption of new Supplier Onboarding Protocol; and (ii) tracking reports received either from Assent or directly from our suppliers, notifying us of risks of Human Rights Abuses within our supply chain and confirming the implementation of mitigation measures to remedy any such risks.

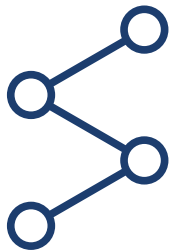
